

Springfield's 2025 St. Patrick's Parade

STAGING AREAS

Groups #1 to #9 and Groups #12 to #29 (First Division) will stage on South Britton Road, except **Groups #3, #15A, #16, #17, #18, and #19 will stage in the Halderman Field Parking Lot on West Springfield Road, and will move to Springfield & Britton prior to the start of the parade. In addition, Groups #10, 10A, and 11** (THE SPRINGFIELD FIRE COMPANY AND SPRINGFIELD AMBULANCE CORPS) and the MORTON-RUTLEDGE FIRE COMPANY (**#11A**) will stage in the 300 block of West Springfield Road on the east side. They will follow the Springfield Police Department (**#9**) and/or The AOH Dennis Kelly Division (**#8**) as they reach the 300 block of W. Springfield Road Rev. NOTE: If attending, the CLIFTON HEIGHTS FIRE COMPANY, will stage behind the MORTON-RUTLEDGE FIRE COMPANY on W. Springfield Road. **Group #12** (SPRINGFIELD TOWNSHIP COMMISSIONERS) will follow the Fire Companies in the line of march.

Groups #32 to #51 (Second Division) will stage on Shelburne Road, led by the BRIAN BORU PIPES & DRUMS and will follow GUTTER BROTHERS (**#29**) in the First Division when the parade starts.

Groups #54 to #66B (Third Division) will stage on Forest Road, led by QUAKER CITY STRING BAND, and will follow DAVY TREE (**#50**) in the Second Division when the parade starts.

Groups #67 through #90 (Fourth Division) will stage on West Leamy Avenue at Spring Valley Road, led by AOH DIVISION 65 (**#67**) and will follow the SPRINGFIELD HIGH SCHOOL BAND (**#66B**) in Third Division.

Any additional units that show up unannounced will be staged behind last unit in Fourth Division..
